

PROCLAMATION

OFFICE OF THE MAYOR OF THE CITY OF FORT SMITH, ARKANSAS TO THE PEOPLE OF THE CITY OF FORT SMITH

WHEREAS, a 15-day filing period was held May 11, 2016 thru noon on May 26, 2016 for the positions of City Director Wards 1, 2, 3 and 4; and,

WHEREAS, only one (1) candidate filed for Ward 1 and Ward 3, and such candidates have been declared elected; and,

WHEREAS, two (2) individuals filed and have been certified as candidates for the position of City Director Ward 2; and,

WHEREAS, four (4) individuals filed and were certified as candidates for the position of City Director Ward 4, which necessitated a municipal primary election held on August 9, 2016 resulting in two (2) candidates to be included on the general election ballot; and,

NOW, THEREFORE, I, SANDY SANDERS, Mayor of the City of Fort Smith, Arkansas, by virtue of the authority vested in me by law, do hereby proclaim that a **municipal general election** will be held for registered voters of Ward 2 and Ward 4 in the city of Fort Smith, Arkansas, on **Tuesday, November 8, 2016** for the purpose of electing a City Director for Ward 2 and Ward 4.
