Under the Arkansas Freedom of Information Act § 25-19-101 et seq., I am requesting an opportunity to obtain digital copies of the following public records maintained by or for Main Street Fort Smith, an entity partially supported by public funds from the City of Fort Smith: Anonymized Raw Response Data: The complete, anonymized data set for the 2025 Downtown Community Survey. This should include all individual entries in their original format (e.g., Excel or CSV), including responses to all multiple-choice and open-ended questions. It's important to clarify, I'm not asking for the PDF already on the website. I'm looking for the raw data. Respondent Metadata: Any non-identifying metadata collected with the survey responses, specifically including zip codes and timestamps of the submissions. Survey Methodology: Documentation regarding the distribution methods for the survey. Under Arkansas Code § 25-19-103, public records include any data compilations from any agency "wholly or partially supported by public funds". The Arkansas Supreme Court has ruled that direct receipt of public funds by a private organization (like the \$12,500 monthly check Main Street FS gets from Fort Smith) triggers FOIA requirements for that organization, aka the "Troutt Brothers rule". Format of Records: I request these records be provided in their native electronic format (Excel, CSV, or PDF) via email to save the city and organization the cost of reproduction. Response Time: As required by A.C.A. § 25-19-105(e), please provide these records within three (3) business days. If more time is needed, please let me know. If you deny any portion of this request, please cite the specific legal exemption justifying the refusal.
